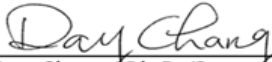

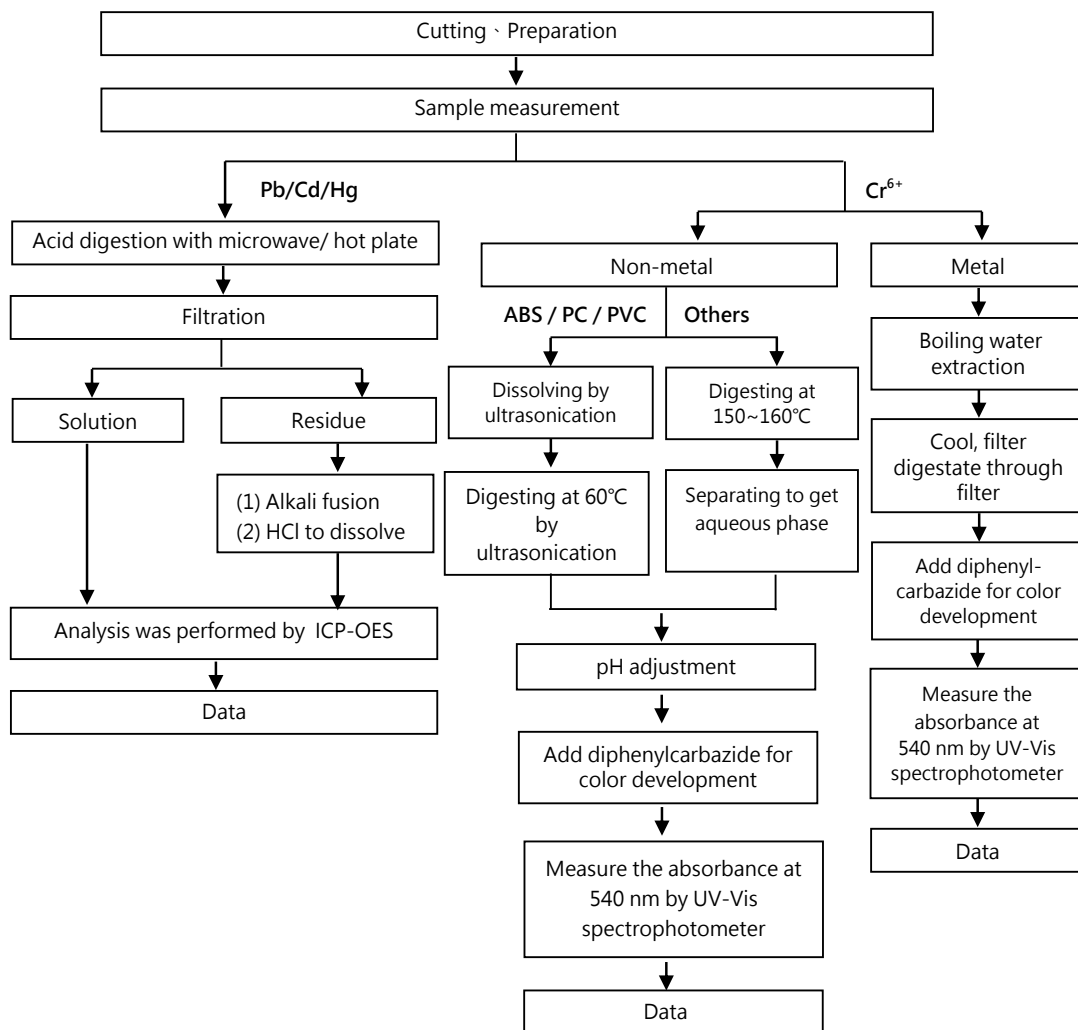

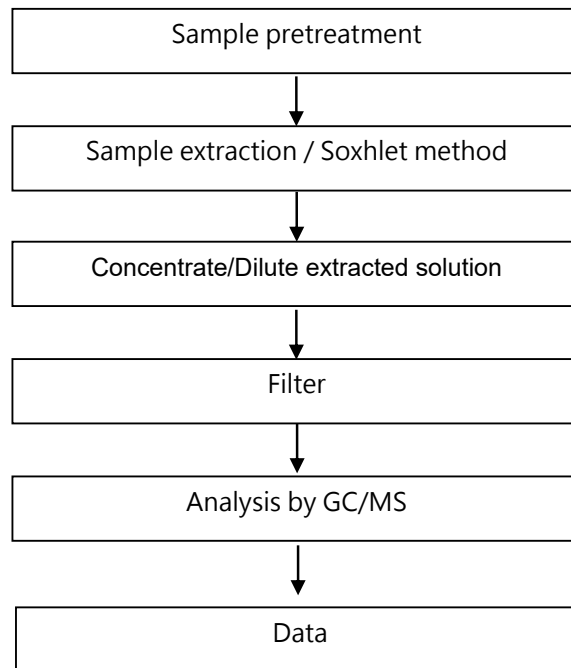
Analytical flow chart of heavy metal

(Cr^{6+} test method excluded)



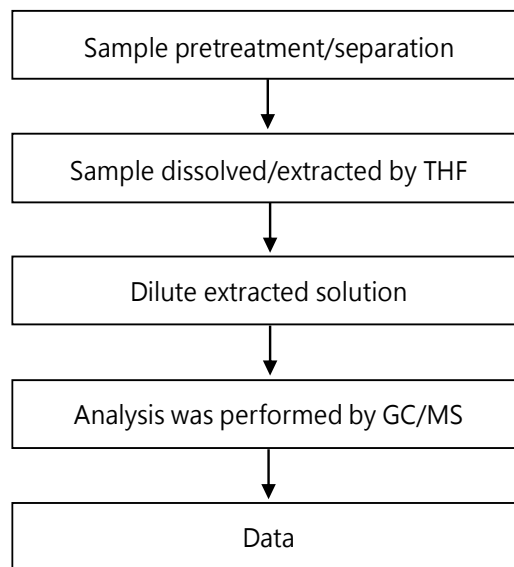
PBB/PBDE analytical FLOW CHART
