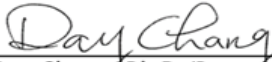

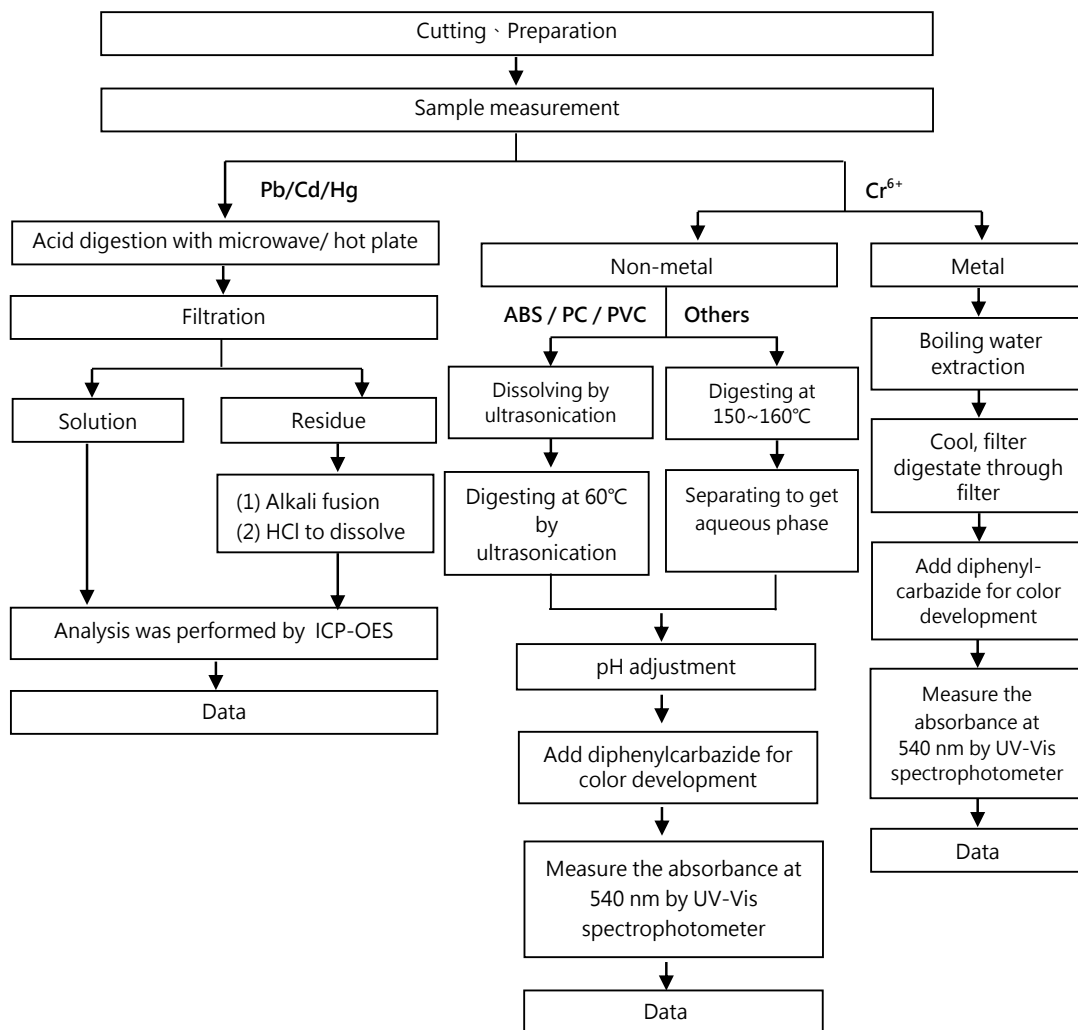

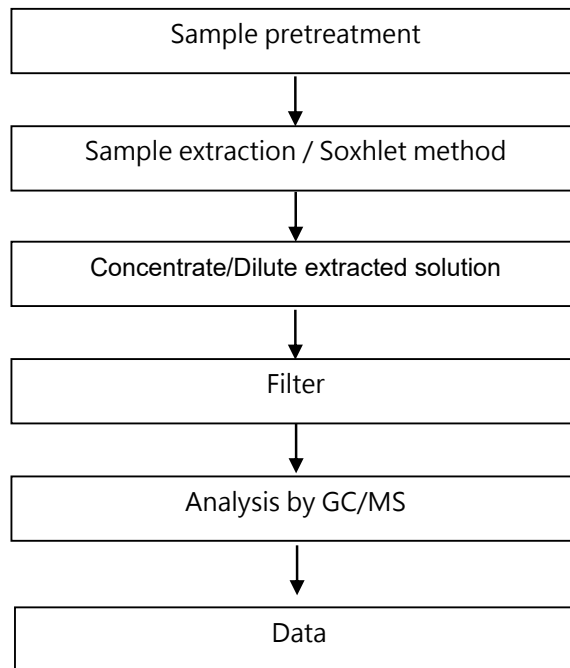
Analytical flow chart of heavy metal

PBB/PBDE analytical FLOW CHART



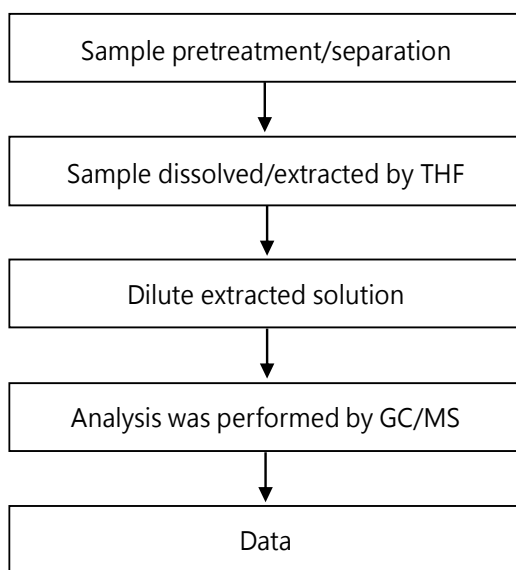
