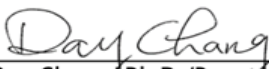

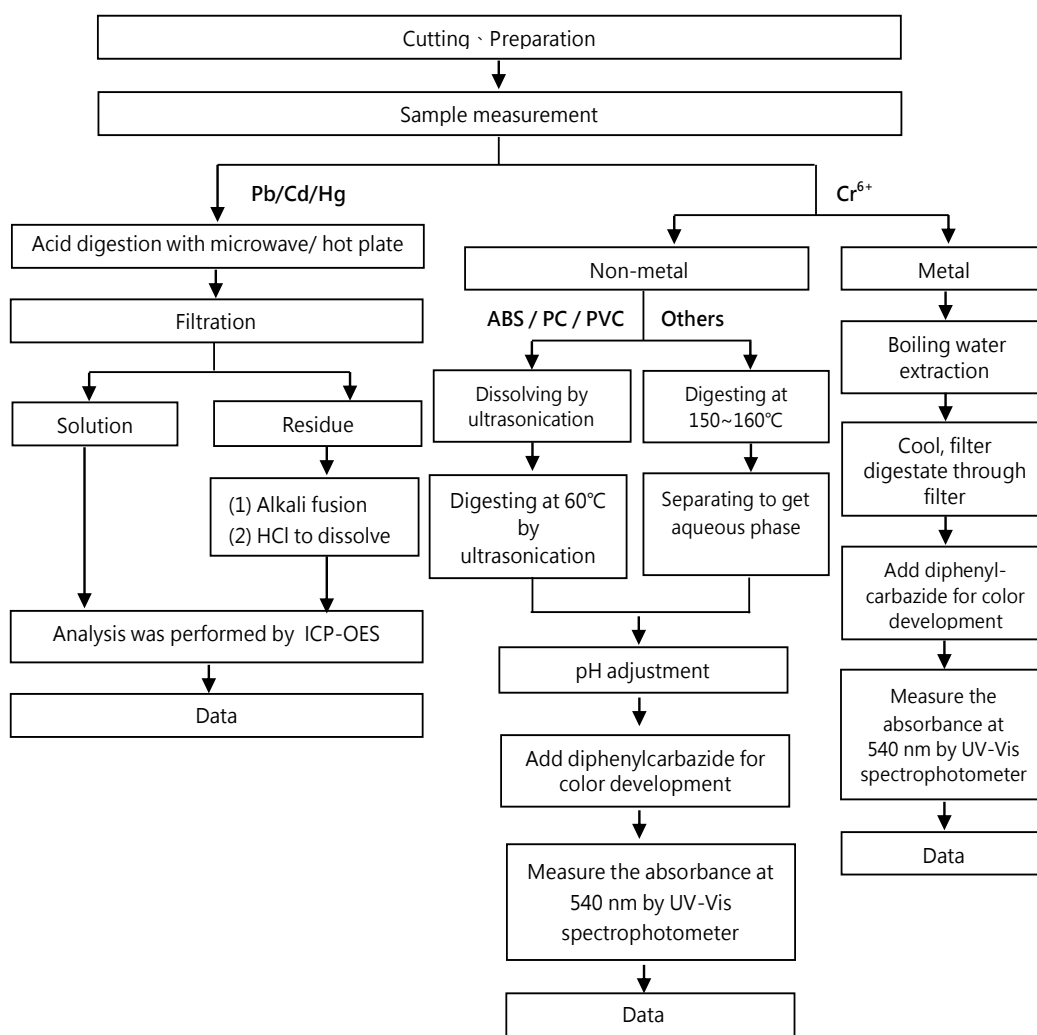

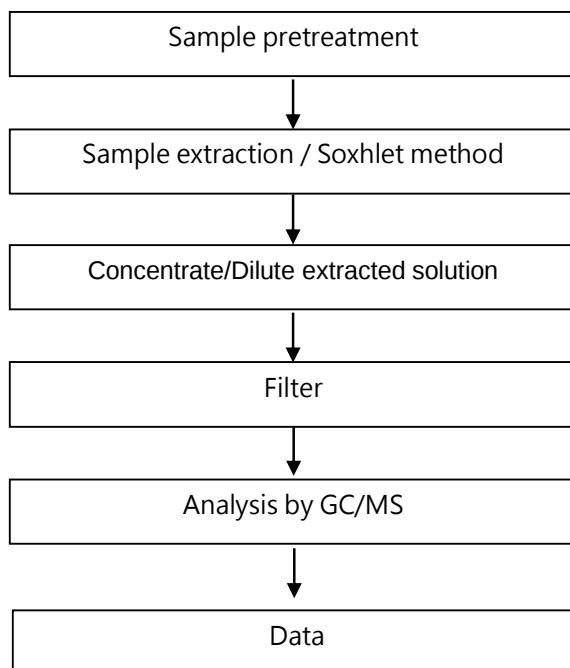
Analytical flow chart of heavy metal

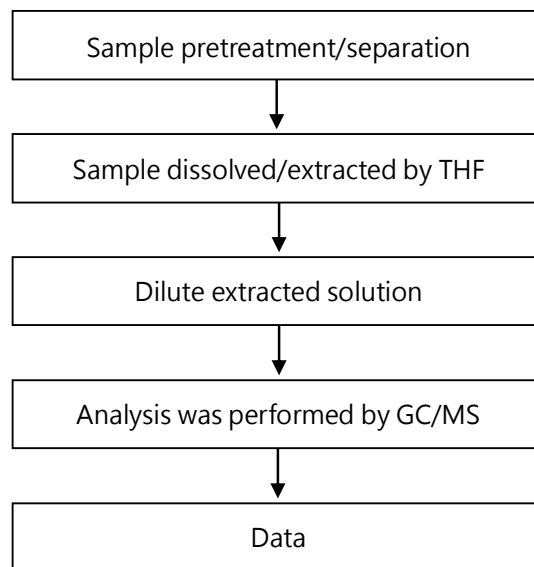

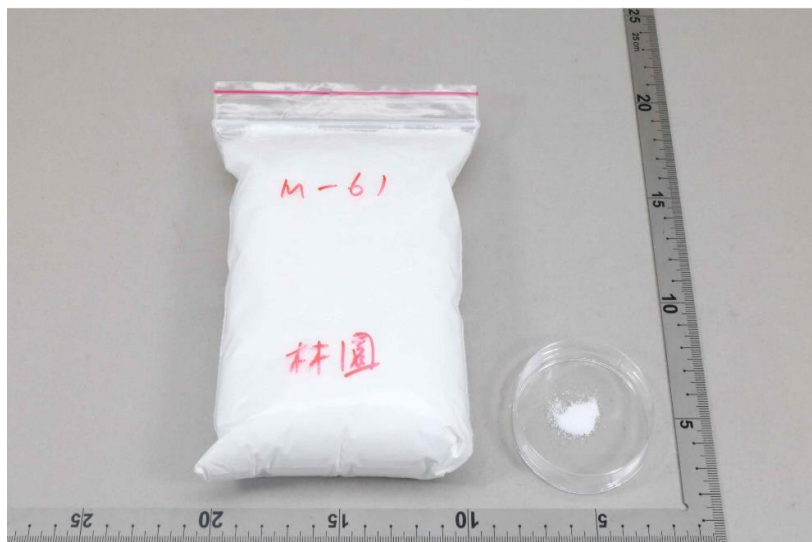
